(CA State Certified)**

**COURSE DESCRIPTION:** CA State Fire Marshal CFSTES certified course. This course provides the students with a basic knowledge of the roles and responsibilities of a Fire Inspector 1 including legal responsibilities and authority, codes and standards, the inspection process, confidentiality and privacy requirements, and ethical conduct, and administrative tasks including preparing inspection reports, recognizing the need for a permit or plan review, investigating common complaints and participating in legal proceedings.
